

# Privacy Policy

## 1. Introduction

This Privacy Policy outlines how Proxysell.com ("We", "Company") collects, uses, discloses, and protects the personal data of users ("You" or "User") and governs visiting <https://proxysell.com/> ("Website"). By using our services, you agree to the terms of this Privacy Policy, Terms of Services and other related rules( collectively herein "Terms and Conditions"). The Company uses your data to provide and improve Service.

## 2. Information We Collect

We may collect the following types of personal data:

- **Identity Data:** First and last name, username, or similar identifier.
- **Contact Data:** Email address, phone number, telegram account data.
- **Technical Data:** IP address, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.
- **Usage Data:** Information about how you use our website, products, and services.
- **Profile Data:** Your username and password, cookies data.
- **Marketing and Communications Data:** Your preferences in receiving marketing from us and your communication preferences.

## 3. How We Collect Your Data

We use different methods to collect data from and about you including through:

- **Direct interactions:** You may give us your Identity, Contact, and Profile Data by filling in forms or by corresponding with us by post, phone, email, or otherwise.
- **Automated technologies or interactions:** As you interact with our website, we may automatically collect Technical Data about your equipment, browsing actions, and patterns. We collect this personal data by using cookies, server logs, and other similar technologies.
- **Third parties or publicly available sources:** We may receive personal data about you from various third parties and public sources.

## 4. How We Use Your Data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances, but not limited to:

- To register you as a new customer.
- To provide and maintain our Service.
- To manage our relationship with you, which will include notifying You about changes, newsletters, marketing or promotional materials and other information.
- To administer and protect our business and this website (including troubleshooting, data analysis, testing, system maintenance, support and reporting).
- To deliver relevant website content and advertisements to you and measure or understand the effectiveness of the advertising we serve to you.
- To use data analytics to improve our website, products/services, marketing, customer relationships, and experiences.

## 5. Data Sharing

We may share your personal data with the following parties:

- **Service providers:** Companies that provide services on our behalf, such as payment processing, data analysis, email delivery, hosting services, customer service, marketing efforts and others.
- **Professional advisors:** Including lawyers, bankers, auditors, and insurers who provide consultancy, banking, legal, insurance, and accounting services.
- **Regulators and other authorities:** Who require reporting of processing activities in certain circumstances.
- **Other cases:** to fulfill the purpose for which you provide it and for any other purpose disclosed by us when you provide the information;

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

## 6. International Transfers

Your personal data may be transferred to and processed in countries other than the country in which you are resident. These countries may have data protection laws that are different from the laws of your country. Where we transfer your personal data to countries outside the European Economic Area (EEA) and USA we ensure that adequate safeguards are in place to protect your personal data. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

The Company will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

## **8. Data Security**

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used, accessed, altered, or disclosed in an unauthorized way. In addition, we limit access to your personal data to those employees, agents, contractors, and other third parties who have a business need to know.

The security of your data is important to us. However, please be aware that no method of transmission over the Internet or method of electronic storage is completely secure. While we make every effort to use commercially acceptable means to protect your personal data, we cannot guarantee its absolute security.

## **9. Data Retention**

We will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

## **10. Your Legal Rights**

If you are a resident of the European Union (EU) and European Economic Area (EEA), you have certain data protection rights, covered by GDPR. If you are a resident of California (USA) you have certain data protection rights, covered by CPPA, CalOPPA. We aim to take reasonable steps to allow you to correct, amend, delete, or limit the use of your Personal Data.

Under certain circumstances, you have rights under data protection laws in relation to your personal data, including:

- The right to request access to your personal data.
- The right to request correction of your personal data.
- The right to request erasure of your personal data.
- The right to object to processing of your personal data.
- The right to request restriction of processing your personal data.
- The right to request transfer of your personal data.
- The right to withdraw consent.
- The right to visit the Website unauthorized.
